INVITATION FOR THE SUBMISSION OF EXPRESSION OF INTEREST FOR THE PURCHASE OF PAKISTAN MOBILE NUMBER PORTABILITY (MNP) ROUTING DATA

Pakistan MNP Database (Guarantee) Limited (PMD), incorporated in 2005 under the Companies Ordinance, 1984 (Now the Companies Act, 2017) is owned by the four Cellular Mobile Operators of Pakistan. The objects of PMD are to own, operate and maintain the Central Database System with the objective to provide Number Portability Services and facilities and to engage in the business of information and communication technology systems and services.

Though PMD, being a private sector entity, is not subject to any procurement laws and rules applicable in Pakistan. PMD believes in providing a level playing field to all its proposed vendors/business partners. PMD's own procurement policy requires it to promote competition and work with the best in the industry.

PMD intends to exclusively sell the Pakistan MNP Routing Data, for use outside of Pakistan, to the successful Bidder to accurately terminate international calls/messages to Pakistan or resell the Pakistan MNP Routing Data provided by PMD to a third-party outside of Pakistan in updating and correcting of its database records, in order to support or facilitate accurate international call/message termination. The incremental Pakistan MNP Routing Data shall be provided on daily basis in the form of an electronic file to the successful Bidder during the term of Agreement/Contract.

The successful Bidder shall not use the Pakistan MNP Routing Data provided by PMD in Pakistan. Furthermore, the successful Bidder shall not resell or transfer this Data to any entity for any use in Pakistan and shall ensure adequate contractual terms with the party/person to whom it may resell or transfer this Data, prohibiting them from using, selling or transferring it to any entity for use in Pakistan.
