**INVITATION FOR THE SUBMISSION OF EXPRESSION OF INTEREST FOR THE PURCHASE OF PAKISTAN MOBILE NUMBER PORTABILITY (MNP) ROUTING DATA**

Pakistan MNP Database (Guarantee) Limited (PMD), incorporated in 2005 under the Companies Ordinance, 1984 (Now the Companies Act, 2017) is owned by the four Cellular Mobile Operators of Pakistan with the objective to own, operate and maintain a Central Database System to provide Number Portability services and related facilities, and to engage in the business of information and communication technology systems and services.

PMD, being a private sector entity, is not bound by any other but its own procurements policies and rules, which require the company to provide a level playing field to all vendors / business partners, and also promote competition to work with the best in the industry.

PMD intends to exclusively sell Pakistan's MNP Routing Data, for use outside of Pakistan, to the successful Bidder for the accurate termination of international calls / messages to Pakistan or resell it to a third-party/parties outside of Pakistan for updating or correcting their database records. The incremental Pakistan MNP Routing Data shall be provided on a daily basis in the form of an electronic file to the successful Bidder during the term of the Agreement/Contract.

The successful Bidder shall not use the Pakistan MNP Routing Data provided by PMD in Pakistan. Furthermore, the successful Bidder shall not resell or transfer this data to any entity for any use in Pakistan and shall ensure adequate contractual terms with the party/person to whom it may resell or transfer this data, prohibiting them from using, selling or transferring / providing it in any form to any other entity for use in Pakistan.

Term of the agreement shall be one year, which may be extended from year to year thereafter, at an agreed escalation formula to be agreed in advance, such that maximum duration of the contract does not exceed 3 years.

12	Duly notarized and legalized Affidavit (admissible in courts of Pakistan and the country of incorporation of the Company) from the authorised legal representative of the Company stating that the Company is neither involved nor any of its directors or major shareholders have been convicted in the past of any offence, contravention, non-compliance of any kind neither in its country of incorporation nor in any other jurisdiction in which it operates.	Notarized Affidavit may be submitted by the bidder on or before the last offer (Bid) submission date. However, submission of the duly legalized Affidavit shall be mandatory for the successful bidder before the execution of the agreement with PMD.
